Contractor: A person or business entity which performs all or some aspects of construction on site.

Supplier: A person or business entity, which provides materials and/or supplies for construction projects.

Industry Professional: A person or business entity which provides professional services directly related to construction projects.

LIMITED MEMBERS do not qualify for membership under any Full Member category, do not have voting privileges and are not eligible for representation on the Association Board of Directors. Limited Member Categories are:

Associate: A person, business entity, organization, agency or entity that prescribes to the principals of the Association, and is dedicated to furthering the objectives and purposes of the Association.

Lifetime: A person that prescribes to the principals of the Association, and is dedicated to furthering the objectives and purposes of the Association, and has worked twenty-five (25) years or more as a contractor, supplier or industry professional, and has worked ten (10) years or more in Wyoming's construction industry, and is no longer actively working full-time in the construction industry.
